
SUBJECT : Presidential Proclamation No. 269 s. 2017 Declaring MAY 1, 2018

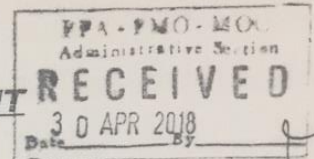


