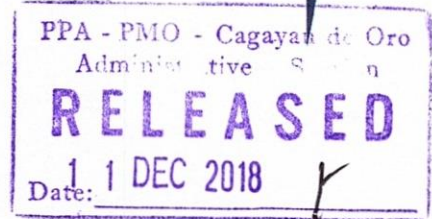

ON 06 NOVEMBER 2018**

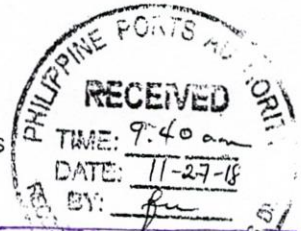


