SUBJECT: CLOSURE OF GATE 1B AND TRANSFER OF ITS FUNCTIONS TO

## MESSAGE:

Please be informed that Jejors Construction, Inc. will be demolishing the existing covered shed at Gate 1B to give way to the construction of a new covered shed. Thus, Gate 1B will be closed temporarily in the duration of the construction effective immediately for the safety of passengers, tenants, personnel, visitors and others using the Passenger Terminal Complex.

Similarly, and in line with the continuing implementation of the International Ships and Port Facility Security (ISPS) Code, the following functions of Gate 1B will be transferred to Gate 1A:

- 1. Entry/exit of pedestrians;
- 2. Entry/exit of vehicles of tenants, shipping lines and LEU personnel allowed to enter the PTC;
- 3. Physical inspection of passengers/pedestrian;
- 4. Screening of baggage/luggage/hand-carried items thru X-Ray machine;



Outgoing passengers without boarding time assignment yet shall proceed to the Well-Wishers Area through the walkway at the Park and Sail and wait for announcement thereat while those already scheduled for boarding shall proceed immediately to the Temporary Facility 1 (pre-boarding).

Moreover, incoming passengers shall use the West Service Road en route to exit to Gate 1A.

This Advisory is only temporary and shall cease upon the completion of the construction of the new covered shed.
