SUBJECT: TEMPORARY STOPPAGE ON THE ISSUANCE OF OVERNIGHT PARKING TICKET AT THE PORT OF CAGAYAN DE ORO

MESSAGE:	
<p>As part of port development, several projects have been implemented specifically at the Passenger Terminal Complex (PTC) of the Port of Cagayan de Oro causing the operational set up thereat to eventually change. These projects have introduced new operational features on PTC instigating some of its existing amenities/facilities to be relocated to other areas or have to be stopped. Further, the ports' traffic flow of vehicles and passengers at PTC have to be reconfigured to conform to the new layout to continually provide safety, security, comfort and convenience to the riding public. And as such, the portion of PTC allocated as parking area for vehicles which shall be parked overnight shall no longer be made available to the public effective immediately as it will be utilized for another purpose.</p> <p>In view of the foregoing and in continuing implementation of International Ship and Port Facility Security (ISPS) Code and to ensure that movement of vehicles at PTC are closely monitored, please be informed that overnight parking at the Park and Sail area of PTC shall no longer be allowed. Thus, issuance of Overnight Parking Ticket and collection of its corresponding fees shall likewise be stopped.</p> <p>However, for clarification purposes on the issuance of Notice of Violation, vehicles/trucks which were left unattended/parked at the ports' operational areas by which, based on records, subject transport unit/s have overstayed thereat, the Port Police Officer on duty/Shift-In-Charge guards shall issue a Notice of Violation to the concerned driver. The same ticket shall be issued to drivers violating the ports' traffic</p>	

rules and other related infractions committed by the drivers/port users inside the port. The Notice of Violation ticket shall be completely filled up by the apprehending officer citing therein the offense committed. The imposition of fines and penalties shall be in accordance to Section 146 of PPA A O 013-1977. After payment was made by the offender, the duplicate copy of the receipt shall be attached to the remaining duplicate and triplicate copies of the Notice of Violation which shall be kept at the PPD Office.

Port Police Officers on duty and Shift-in-Charge guards shall ensure strict implementation of this order.

This Advisory takes effect immediately and shall remain in force, unless sooner revoked or otherwise amended by this Office.
