SUBJECT: Port Facility Security Officer (PFSO) Certification

Dear Mr. Butaslac Jr.,

I am writing to inform you that the Office for Transportation Security (OTS) in collaboration with the Philippine Ports Authority (PPA) Davao will be conducting a series of activities relative to the implementation of the Memorandum of Agreement on Cooperative Enforcement between OTS and PPA. One of the activities is the conduct of Oral Examination to the applicants for Port Facility Security Officer (PFSO) Certification by the OTS Certification Jury (CJ). Oral Examination is an evaluation process, through interview by the CJ, which test the communication skills and validates the competency of an applicant.

The objective is to give the PFSOs of Regions X and XI an opportunity to comply with the requirements of the National Program and the ISPS Code, to ensure that the PFSOs possess the competency to perform the assigned function at an acceptable level.

Therefore, I would encourage your PFSOs to apply and appear before the OTS CJ for oral examination on July 02, 2019, at 8:00 AM PPA Davao Office, Conference Room, Panabo City Rd, Buhangin, Davao City, Davao del Sur. However, applicants for PFSO regular certification, a written examination is required and it will be conducted by the OTS Secretariat at 10:00 AM to 4:00 PM on July 01, 2019 at PPA Davao Office, Conference Room. This is a requirement to qualify or proceed in the next step of certification, the OTS CJ oral examination.
