2. Security Threat Situation:

- a. ISIS members reaffirmed their allegiance to continue fighting after the death of its leader Abu Bakr al-Baghdadi. Southeast Asia has long been an important focus for ISIS. In the Philippines, ISIS has claimed responsibility for four (4) suicide bombings since July 2018, after fighting its toughest battle when it seeks to establish its stronghold in Marawi in 2017. The Philippines, Indonesia and Malaysia braces for retaliation by ISIS loyalists including "lone wolf" attacks by locals radicalized by the terror group's powerful online propaganda. DND said ISIS remains capable and dangerous and its influence has taken a hold among unschooled Muslim youth in Mindanao. Counter Extremism Project executive director David Ibsen said the terror group would use al-Baghdadi's death as an opportunity to expand its online presence and build alliances. There is much more to be desired to address terrorism and extremism, a concrete step in this regard, despite the death of al-Baghdadi with the changing nature of war. ISIS is not yet over because it still has a strong ecosystem of ardent supporters of its cause including in the Philippines. The group's ideology will endure beyond al-Baghdadi thus the threat it poses remains stable. ISIS had already moved its mandate for its followers to a "do-it-yourself" style of jihad, and further inspired by "pro-ISIS" thinkers/jihadists who have access to its online propaganda.
- b. Be that as it may, ISIS has already built a legacy in the country it needed to in order to rally around itself, and Baghdadi leaves behind a jihad strategy that will not end with him. Former Al-Qaeda's Southeast Asian arm Sofyan Tsauri said that the aim of ISIS in the region is to bring down its secular governments, a strategy it called its "grand agenda." Tsauri said it plans to bring together all the Southeast Asian countries under a caliphate with the southern Philippines as the capital.
- C. The killing of al-Baghdadi closely coincides with the holding of the 30th Southeast Asian Games in the country. Although there were no reported specific plans to attack the event, it could be seen as a highly attractive target by ISIS to redeem its setback and to seek new territory. It should be noted that the group of ASG leader Hajan Sawadjaan recently renewed their pledge of allegiance to ISIS. The group of Sawadjaan was responsible for at least four suicide attacks in the county since July 2018, making him a more viable leader for the ISIS-Philippines. The message of the demised ISIS leader in Tagalog version emboldened Daesh-inspired LTGs to

operationalize plans to conduct bombings in key cities and urban areas including Metro Manila. Also, there have been reports of presence of foreign nationals in the country, possibly as sleeper cells. Although, LTGs remain confined to their strongholds in Mindanao, their possible presence and supporters in the areas of the SEAG venues cannot be discounted.

 In the light of the possible threat to the transportation system of the country, OTS Transportation Security Levels for November 2019 remain as follows:

SECURITY LEVELS	TRANSPORTATION SECTOR
SECURITY CONDITION (SECCO) 2	All airports in Metro Manila, Luzon, the Visayas and Mindanao
SECURITY LEVEL 1, WITH ENHANCED SECURITY	All seaports in Metro Manila, Luzon, the Visayas and Mindanao
ELEVATED/ENHANCED SECURITY MEASURES	All land mass transportation facilities in Metro Manila, Luzon, the Visayas and Mindanao

- 4. In this regard, the following enhanced security/target-hardening measures are recommended to be implemented:
 - Stringent security screening and tighter access control measures for persons, bags and vehicles, especially with the end in view of thwarting any possible suicide attack;
 - Deployment of more security personnel and K9 units, especially at the perimeter or landside areas, and employment of unpredictable methods and utilization of security equipment for frequent/random inspections;
 - c. Deployment of quick-response units for emergency security situations;
 - d. Enhancement of background checks/counterintelligence efforts to neutralize insider risks that may be exploited by terrorists to smuggle explosive devices into the facility or sabotage its operations;
 - Implementation of other contingency measures to detect or deter, delay or dilute any terrorist threat; and,
 - Coordination with intelligence/security units for the purpose of continually monitoring and assessing the threats to the security of the transportation systems of the country.
