SUBJECT: IMPLEMENTATION OF HEIGHTENED SECURITY ALERT IN ALL PORTS UNDER PMO-MOC DURING THE OBSERVATION OF PASKO 2019

<p>In view of the continuing implementation of International Ship and Port Facility Security (ISPS) Code and in compliance with the unnumbered memoranda issued by the Assistant Secretary for Special Concerns of Department of Transportation dated 8 November 2019 and the General Manager of PPA-HO dated 28 November 2019 to ensure safety, security, comfort and convenience of the riding public during the observation of Pasko 2019, all Port Police Officers, Terminal Managers and security personnel detailed at PMO MOC are hereby directed to implement Heightened Security Alert within their area of jurisdiction from 16 December 2019 to 5 January 2020. All are enjoined to intensify target-hardening measures and implement enhanced security procedures at their respective ports such as but not limited to, stringent screening, tighter access control and other target hardening measures. It is reiterated however, that security level of the port remains at Level 1; though, security measures equivalent to that of higher security levels, whichever is applicable, may be adopted and implemented.</p> <p>Hence, to ensure continuous presence and visibility of Port Police Officers and security personnel within the PMO's jurisdiction during the aforesaid period, applications for leave of all PPOs and security guards and the scheduled rest days of all PPOs are hereby suspended. All previously approved leave applications are likewise deemed recalled/revoked.</p>

This Advisory takes effect immediately and shall remain in force, unless sooner revoked or otherwise amended by this Office.
