<b>MESSAGE:</b>  Pursuant to the unnumbered memorandum from the The Acting Department Manager of Port Police Department dated 7 January 2020 and in view of the continuing implementation of International Ship and Port Facility Security (ISPS) Code to ensure safety and security of the riding public, disseminated herewith is the information received from NICA – Region 9 and other intelligence community with regards to the alleged plan of ASGSL PURUJI INDAMA to conduct another bombing particularly in Isabela, Lamitan and Zamboanga City.  Report further states that more or less twenty (20) IEDs containing with ammonium nitrate inside a 1.5 plastic bottles were allegedly manufactured by a certain Abu Mudi in an undisclosed Barangay, Municipality of Ungkaya Puka, Province of Basilan. Said IEDs were already transported in Zamboanga City thru unknown ASG couriers, onboard on an unmarked motorized pump boat and have been allegedly unloaded in the coastal barangay of Sacol Island and Ana Blanco, East Coast of Zamboanga.  Moreover, concerned personnel are enjoined to be extra vigilant in monitoring the security situation within your respective AOR and nearby areas. You are likewise advised to upgrade intelligence gathering, monitoring, police visibility and implement target hardening measures. Coordinate closely with the friendly forces and intelligence community operating within your AOR and report immediately thru the PMO's Command Center any received information relating to the aforesaid intel	

report and/or other relevant information that may affect the port security for further assessment and validation.

This Advisory takes effect immediately and shall remain in force, unless sooner revoked or otherwise amended by this Office.
