



<b>MESSAGE:</b>	
<p>As directed by the General Manager and in view of the recent development on Corona Virus currently plaguing China, all frontline personnel of this PMO are directed to wear the appropriate face mask during duty and as necessary, especially during the expected influx of passengers on Lunar New year. This is an expedient and necessary measure to prevent the spread of the infectious virus. The PSD and the PPD are enjoined to coordinate closely with the DOH/Bureau of Quarantine in the institution of this measure.</p> <p>The Administrative and Finance Divisions are advised to procure the face masks appropriate for this particular virus and immediately distribute the same to all personnel. Terminal Managers of TMOs Balingoan, Camiguin and Opol are likewise advised to work closely with their respective Local Government Units and procure and provide facemask to all personnel.</p> <p>Cargo handling operator, shipping lines and all other stakeholders are likewise advised to institute the same measure by providing the appropriate face mask to all its employees and workers in the port</p>	

Further, security level of all ports directly and administratively under the jurisdiction of PMO MOC shall remain at Security Level 1 with enhanced security measures.
