SUBJECT: TEMPORARY CLOSURE OF GATE 1-C AND UTILIZATION OF GATE 1-A AS
THE TEMPORARY EGRESS POINT OF DISEMBARKING PASSENGERS AT
THE PASSENGER TERMINAL COMPLEX OF THE PORT OF CAGAYAN DE

MESSAGE:

In view of the demolition on portion of the old covered walkway situated along the East Service Road inside the Passenger Terminal Complex (PTC), Gate 1C will be temporarily closed effective immediately to allow construction of the new covered walkway connecting Gate 1B to the new Passenger Terminal Building presently under construction.

Thus, to ensure orderly, safe and secured egress procedures during arrival of passenger vessels and in line with the continuing implementation of International Ship and Port Facility Security (ISPS) Code, Gate 1A, which is located at West Service Road shall now be the temporary egress point of disembarking passengers exiting the PTC. Thus, the following guidelines shall be observed, to wit;

- 1. Jejors Construction Corporation shall provide temporary barriers from the exit point of Arrival Area across the East Service Road;
- 2. The guard assigned at Arrival Area shall advise the disembarking passengers to take the West Service Road en route to Gate 1A and he/she shall provide added directional instructions, if necessary;
- The security personnel assigned at Gate 1A shall only open the said gate when disembarkation process of the arriving vessel/s has already commenced;
- 4. The security personnel assigned at Gate 1A shall ensure that no vehicle can gain access thereat except those expressly allowed by the Authority. Further,

he/she shall ensure that no vehicle, canvasser or barker is blocking the passageway in order to guarantee smooth and unobstructed flow of inbound passengers;

5. Porters along with their pushcarts may gain access thereat during the duration

of disembarkation process only;

6. Gate 1A shall be immediately close when disembarkation of passengers has come to an end;

7. The security personnel previously deployed at Gate 1C for additional manpower during arrival of passenger vessels shall now be deployed at Gate 1A to render the same purpose;

8. Vehicles of concessionaires previously allowed by the Authority to park on the East Service Road shall now be transferred at the Park and Sail area;

9. Gate 1C shall remain closed and no vehicle can gain access thereat unless otherwise authorized by the Authority;

10. Gate 1B shall remain as the ingress point of passengers en route to PTC.

Attached for your ready reference and guidance is the ports' PTC layout depicting therein the directional instructions en route to Gate 1A.

This Advisory is only temporary and shall cease upon the completion of the aforesaid project unless sooner revoked or amended by this Office.
