<p>This has reference to PABA No. PPD 006-2020 which was issued last 12 February 2020 by the Authority with the subject "Inclusion of Taiwan for Travel Ban due to 2019 Novel Corona Virus Acute Respiratory Disease (2019 nCoV-ARD).</p> <p>Please be respectfully informed that the travel restrictions previously imposed upon Taiwan has now been lifted as advised by the Inter-Agency Task Force for the Management of Emerging Infectious Disease. Thus, all applicable provisions that may be attributed to PABA No. PPD 006-2020 has likewise been rescinded.</p> <p>Moreover, please be further informed that as directed by the Department of Health, 2019 nCoV-ARD already has an official name and same shall be called COVID-2019 which stands for Corona Virus Disease-2019. As such, the Authority shall now use the term "COVID-2019" in all its future issuances appertaining to the said virus henceforth.</p> <p>This Advisory takes effect immediately and shall remain in force, unless sooner revoked or otherwise amended by this Office due to the evolving situation as advised by concerned Health and Maritime agencies.</p> <p>For guidance, ready reference and appropriate action.</p>
