Respectfully disseminating herewith copy of Notice to All Mariners No. 071-2020 issued by the Philippine Coast Guard dated 17 March 2020 prescribing guidelines for the management of Corona Virus Disease 2019 (COVID-19).

In view hereof, concerned ship owners/operators and vessel crews are advised to strictly observe and adopt the measures recommended by PCG as cited in the herein PCG NOTAM (hereto attached).

Further, in case a vessel requests for disembarkation of its crew/s for purposes of facilitating arrival and departure formalities as well as acquiring ship provisions and other essentials, the same shall be referred to the Philippine Coast Guard for appropriate clearance.

Port Police Officers on duty and Shift-In-Charge, Gate 4 and roving guards shall ensure implementation of this Advisory.

## NOTICE TO ALL MARINERS NUMBER 071-2020

Notice is hereby given to all mariners and other parties concerned that:

- Reference: Memorandum from the Executive Secretary dated 16 March 2020
  re Community Quarantine Over the Entire Luzon and Further Guidelines for
  the Management of the Corona Virus Disease 2019 (COVID-19) Situation
- 2. Per above reference, "No Sail" policy shall be enforced to all domestic passenger vessels and passenger motorized bancas, to include private watercrafts/pleasure yachts, calling to and from any seaport in Luzon Island, and the provinces of Batanes, Catanduanes and Palawan effective 171200H March 2020 up to 141200H April 2020.
- 3. Only cargo, fishing and government vessels are allowed to sail and enter the ports of the above-mentioned areas for the purpose of carrying the basic food supplies and other logistics and material requirements for manufacturing of commodities, subject to the conduct of PCG's health protocol for domestic vessels, and in the case of foreign vessels, in coordination with the Bureau of Quarantine.
- 4. Henceforth, ship's crew of all the domestic and foreign cargo vessels, during the ship-to-port interface or cargo operation (loading / unloading), must stay onboard the vessel, or in the extreme case that their services so require during cargo operation, must stay within fifty (50) meter radius from the vicinity of the vessel they are working with. Ship's crew must follow at all times social distancing by maintaining one (1) meter distance from the port workers and the local populace.
- 5. All domestic and foreign ships/watercrafts are advised to take notice of this directive.
- 6. The cooperation of all concerned maritime stakeholders are therefore enjoined.
