Pursuant to R.A No. 11469 also known as the "Bayanihan to Heal as One Act", memorandum from the Executive Secretary and relevant IATF Resolutions and as part of the measures to facilitate undisrupted supply of basic commodities and services amid the implementation of Community Quarantine due to COVID-19 crisis, *Item No.* 2 of PPA Memorandum Circular No. 13-2020 previously issued by the Authority dated 3 April 2020 is hereby amended to further ensure unhampered access of authorized truck drivers and helpers while transporting such cargoes to/from the ports.

In view hereof, respectfully disseminating herewith PPA Memorandum Circular No. 14-2020 dated 7 April 2020 (herein attached) for your ready reference. AMENDMENT OF MEMORANDUM CIRCULAR NO. 13 -

2020

Pursuant to Republic Act No. 11469, otherwise known as the "Bayanihan to Heal as One Act", the Memorandum of the Executive Secretary dated March 28, 2020, and relevant IATF Resolutions, and as part of the measures to facilitate and/or minimize disruption to the supply chain, especially for the basic commodities and services to the maximum level extent possible, Item No. 2 of PPA Memorandum Circular No. 13-2020 is hereby amended to read as follows:

- "2. Truck drivers and helpers shall be allowed unhampered access to and from the ports to enable them to proceed to their final destination, subject only to safety and health measures being implemented by the Philippine Ports Authority (PPA), as follows:
 - a. Accomplishment of Entry Protocol;
 - b. Thermal scanning:
 - c. Disinfection; and
 - d. Referral of symptomatic persons to the Department of Health (DOH) or Local Government Unit (LGU) Health Office."

All issuances inconsistent herewith are hereby revised or modified accordingly.

This Memorandum Circular takes effect immediately.
