Please be guided accordingly.

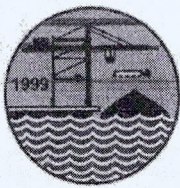


This is to formally amend the previous letter forwarded to your office regarding the temporary suspension of cargo handling operations.
