
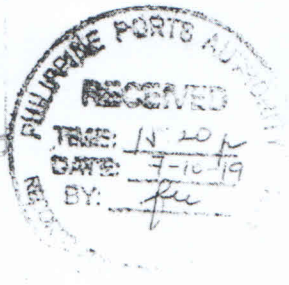
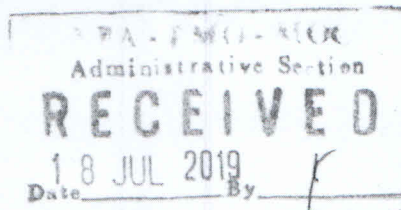

MESSAGE: Disseminating herewith is PPA Administrative Order No. 05-2019 dated 8 July 2019 Re: "Non-Imposition of Weighing Fee for Domestic Outbound Laden Containers and RO-RO Cargo Amending PPA Administrative Order (AO) No. 06-2011" providing guidance and compliance for the non-imposition of weighing fees pursuant Board Resolution No. 2814. Please be guided on Item Nos. 2 and 3 of the A.O., that notwithstanding the non-imposition of weighing fees, 100% MANDATORY WEIGHING of all domestic outbound laden containers and RORO vehicles shall be enforced and that commencement on the non-imposition of weighing fees shall take effect on 1 January 2020 . SUBJECT : Non-Imposition of Weighing Fee for Domestic Outbound
Laden Containers and RO-RO Cargo Amending PPA
Administrative Order (AO) No. 06-2011

Pursuant to Board Resolution No. 2814, the following are hereby issued for guidance and compliance:

1. Weighing Fee **SHALL NOT BE IMPOSED** on:
 - 1.1 All domestic outbound laden containers; and
 - 1.2 All RO-RO vehicle Types 3 and 4, provided such vehicles are registered for commercial purposes and loaded with commercial cargo, as follows:

Vehicle Type	
3	4
Light delivery truck Van, pick-up truck, PUJ	Stake truck, heavy delivery truck, passenger/tourist bus, prime mover, tractor head with or without trailer/chassis, 10-wheeler

2. Commencement on the non-imposition of weighing fee shall take effect January 1, 2020.
3. **100% MANDATORY WEIGHING** of all domestic outbound laden containers and RO-RO vehicles **shall be enforced**.
4. All RO-RO cargo including vehicles which exceed the allowable maximum gross weight upon weighing in the port will not be allowed to board unless weight is reduced to allowable limit.
5. All RO-RO vehicles which have registered fixed weight and have no loaded commercial cargo and empty containers which should be opened for inspection shall be exempted from weighing.

This Order amends PPA AO No. 06-2011 and shall take effect 15 days after publication in newspaper of general circulation.
