No. 14 s.2019 from the Provincial Governor Re: Temporary, Total Prohibition on the Entry into the Province of Misamis Oriental of Live-Hogs, Pork Related Products and By-Products, including but not limited to Frozen Boar Semen Coming from the Entire Island of Luzon providing guidance and compliance to protect the public and the thriving hog industry and its allied business in Misamis Oriental. Please be guided on Section 1 of said E.O. has declared unlawful for anyone to bring into the Province of Misamis Oriental any and all kinds of pork and pork-related food products in whatever form or quantity they may be, including those which are for consumption purposes only; preserved extended or frozen boar semen in whatever quantity or form; and live hogs transported into or passing through its territorial jurisdiction. Executive Order No. 014
Series of 2019

TEMPORARY, TOTAL PROHIBITION ON THE ENTRY INTO THE PROVINCE OF MISAMIS ORIENTAL OF LIVE HOGS, PORK RELATED PRODUCTS AND BY-PRODUCTS, INCLUDING BUT NOT LIMITED TO FROZEN BOAR SEMEN COMING FROM ENTIRE ISLAND OF LUZON

WHEREAS, on the 11th day of September 2019, Executive Order No. 2019-13 entitled "Creation of Task Force ASF Free Misamis Oriental and the Implementation of a Temporary Ban on the Entry of Pigs and Pork Products and By-products to the Province of Misamis Oriental from certain affected areas of Luzon was issued;

WHEREAS, the Province of Misamis Oriental considers ASF even more as a serious concern, it being the northern gateway to the entire Mindanao area which collectively account for about 40% of total hog industry volume;

WHEREAS, swill feeding has been pointed out in many such outbreaks, in Luzon and elsewhere abroad, as the culprit of the widespread transmission of this much dreaded economically crippling swine disease;

WHEREAS, this ASF scare gripping all hog producing provinces outside of Luzon gives more compelling reasons for an immediate implementation of stricter measures by amending Executive Order No. 2019-13, to protect the public and the thriving hog industry and its allied businesses in Misamis Oriental by banning entry of live hogs, pork related products and by-products, including but not limited to frozen boars semen coming from the entire island of Luzon;

NOW, THEREFORE, I, YEVGENY VINCENTE B. EMANO, Governor of the Province of Misamis Oriental, Philippines, by virtue of the powers and authority vested in me under Section 16, in relation to Section 465 (b) (2) (iii) of the Local Government Code of 1991, do hereby promulgate:

Section 1. Calling the total prohibition on the entry into the Province Of Misamis Oriental of all Luzon-sourced swine/pigs, frozen boar semen, canned goods, like meat loaf, sausages, corned pork, mechado, etc., and other processed pork meat products, including but not limited to bacon, tocino, longganisa; chicharon, hams, hot dog, fresh native sausage (chorizo), meat balls, siopao/siomai, etc., until such time that a declaration is made by the Bureau of Animal Industry (BAI) of the assurance of the safety in the swine industry on the basis of traceability;

It is hereby declared unlawful for anyone to bring into the Province of Misamis Oriental any and all kinds of pork and pork-related food products in whatever form or quantity they may be, including those which are for consumption purposes only;

preserved, extended or frozen boar semen in whatever quantity or form; and, live hogs transported into or passing through its territorial jurisdiction.

Section 2. Installation of 24/7 veterinary quarantine stations, as may be necessary, augmented with deputized elements of the Philippine National Police, or the military, to man the checkpoints to assist in the strict implementation of quarantine procedures, like disinfectant spraying of motor vehicles' wheels and compulsory alighting of passengers for foot-bathing, and cargo inspection of all closed meat delivery vans, whether refrigerated or not, as the case may be;

This includes setting up of truck/vans disinfectant spraying and foot bath stations in all seaports and airports within the Province of Misamis Oriental;

Section 3. Confiscation of prohibited items, pork and pork-related products, frozen boar semen at the quarantine stations for disposal on specially designated receptacles at the quarantine stations;

It shall be the duty of every person passing or entering the territorial jurisdiction of the Province of Misamis Oriental to voluntarily surrender and dispose of prohibited items, such that concealing them shall be considered unlawful and subject to imposition of fine to be determined by the Provincial Multi-Agency ASF Task Force.

Section 4. Adoption and strict implementation of D.A. Administrative Order (AO) No. 04, Series of 2019, on the Reiteration of Food Safety and Veterinary Quarantine Procedures, and, AO No. 08, Series of 2019, or the Revised Guidelines on the Local Movement of Swine, Pork, Pork Products and Pork By-Products outside Disease Outbreak Areas;

Section 4.1 In relation to **Section 1.** All swine commercial farms will be allowed to move or transport live hogs to be brought in the slaughterhouse within or passing through the Province of Misamis Oriental provided they have adequately complied with the veterinary quarantine requirements, such as, but not limited to, Veterinary Health Certificate (VHC), Veterinary Shipping Permit (VSP), valid within 7 days after its date of issuance, BAI Livestock Handler's License, and BAI Livestock Transport Carrier License;

Additional documents to be presented in designated Animal Quarantine Checkpoints are required for breeder animals, as follows: (1) Negative Laboratory Test Results of Different Swine Diseases, and, (2) BAI Certificate of Laboratory Compliance (as written in DA AO No. 13, Series of 2012);

Moving cargoes of live hogs that fail to comply with the foregoing documentary quarantine requirements shall be stopped and refused entry into and passage through the Province of Misamis Oriental at the quarantine stations, or wherever transport vehicles are intercepted and found unlawfully travelling without proper clearances, and subject to immediate transport back to its place of origin after proper documentation and collection of appropriate fine;

Section 4.2 In relation to **Section 1.** Providing for specific documentary requirements to cover moving cargoes from the government accredited slaughterhouses,

Accredited Cold Storage Warehouse (ACSW), or provinces or ports of origin, for newly slaughtered, frozen, raw or fresh pork, as the case may be:

- a. For locally produced pork – Meat Inspection Certificate (MIC) issued by the National Meat Inspection Service (NMIS) or its deputized Local Government Unit (LGU) meat inspector, and Veterinary Shipping Permit (VSP) from non-ASF affected areas, valid within 7 days after its date of issuance;
- b. For imported pork and meat products – Certificate of Meat Inspection (COMI) from NMIS, and VSP, valid within 7 days after its date of issuance;
- c. For uncooked processed pork and pork products – License to Operate (LTO) and Certificate of Product Registration (CPR) issued by the Food and Drug Administration, and VSP, valid within 7 days after its date of issuance;

Section 4.3 All moving cargoes with incomplete requirements will be treated accordingly:

- a. For live animals – Transport of live animals with incomplete veterinary documents which are apparently healthy upon inspection will be held and given 24 hours to complete required documents, otherwise will be ordered return to origin; however, cargoes with dead or sick animals shall be confiscated and disposed of accordingly by apprehending authorities;
- b. For meat and meat products – Shipments of cooked meat with incomplete shipment documents will be held and given 24 hours to complete required documents, otherwise will be ordered to return to origin; Shipment of semi-cooked and raw meat with incomplete shipment documents will be held and given 24 hours to complete required documents, otherwise will be confiscated and disposed of accordingly by apprehending authorities; All shipments without the required shipping condition and handling such as refrigeration, and without proper documents will be confiscated and disposed of immediately;

Section 4.4 Cargoes with falsified and tampered documents will be confiscated at the animal quarantine checkpoints.

Section 5. Directing local chief executives to strengthen biosafety, hygiene and sanitation standards in slaughterhouses/abattoirs, public markets, and live animals auction markets, in their respective areas of jurisdiction, compliance of which is subject to inspection by the Provincial Multi-Agency ASF Task Force;

Furthermore, to conduct ASF awareness drives and educate the backyard farmers on the need to report diseased pigs for investigation and not to sell the same; And, should there be mortalities, to bury the dead pigs 6 feet below the ground and not to throw these anywhere, e.g., empty lots and rivers, etc.. Lastly, Local Chief Executives shall form their “Quick Response Team” for immediate investigation and control of any disease outbreaks.

Section 6. Funding. Funds shall be provided for this purpose. All expenses to support the activities of the Provincial Multi-Agency Task Force ASF-Free Misamis Oriental, for the implementation of this Executive Order shall be charged against the funds of the Office of the Provincial Governor, or any other funds as may be available;

Section 8. Effectivity. This Executive Order shall take effect immediately and shall remain effective unless sooner revoked or modified.
