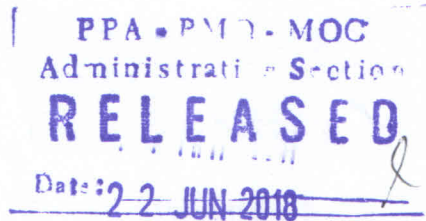

**SUBJECT :** ISSUANCE OF CARGO AND NON-CARGO/LIGHT VEHICLE STICKER/PASS

In accordance with the International Ship and Port Facility Security (ISPS) Code and pertinent PPA regulations and Standard Operating Procedures on access control of vehicles, please be respectfully informed that this Office now issues the annual vehicle sticker/pass for cargo and non-cargo/light vehicles for the CY 2018.

Port users with non-cargo/light vehicles and with legitimate business or purpose inside the port may apply for the said sticker/pass at the Port Police Division Office located at the Access Control Gate, Gate 4, PMO-Misamis Oriental/Cagayan de Oro subject for the evaluation and approval by the Authority. Subject sticker/pass has a minimal administrative fee of Php 84.00 inclusive of 12% VAT and shall be honored by the port security personnel at Gates 1A, 3 and 4 only.

However, for cargo sticker/pass, only those permittees engaging in trucking services and with duly issued Permit-To-Operate (PTO) from the Authority are entitled for the aforesaid stickers/pass after submission of the required documents and payment of all applicable fees. This sticker/pass shall be honored by the port security personnel at cargo port gates only and has an administrative fee of Php 112.00 inclusive of 12% VAT. This non-transferable sticker/pass shall be posted at the upper right hand corner of the vehicle's windshield conspicuous enough to be seen by security personnel.

As a matter of port policy, it shall be construed that the issuance of these stickers/passes is a mere privilege and not a matter of right and bearers of said pass are not exempt from routine security inspection or access prohibition to areas designated as restricted areas for security purposes, especially during Heightened Security Alert Levels. Further, despite the possession of such sticker/pass, the Authority may disallow entry or escort the vehicle to exit the

port premises after such vehicle has found to have safety and security deficiency/ies during inspection upon entry at access gates or during random inspection at the ports' operational areas. Thus, access privilege of such vehicle/s can only be reinstated after repairing and complying appropriately all the deficiency/ies noted by the Authority.
