### 1. References:

COVID-19 dated March 10, 2020;

d. Memorandum from the Executive Secretary re: Community Quarantine Over the Entire Luzon and Further Guidelines for the Management of the Corona Virus Disease 2019, dated March 16, 2020;

e. CPNP approved memo from Dir, CSG, with subject: Recommendations Pertaining to the Enhanced Community Quarantine, dated March 17,

2020; and

f. Republic Act No. 11469 or the \* Bayanihan to Heal as One Act\* dated

March 24, 2020.

- 2. The entire country is faced with unprecedented challenges as a result of the pandemic, hence a vast majority of government resources are re-directed to thwart this threat. Even SOSIA's primordial resource, its personnel, was included and tapped to augment to various government measures/activities. By this fact, the Office transactions are compromised, even the skeleton workforce, due to inavailability of the reserve and admin personnel after getting positive during the conduct of Rapid Test (method) by PNP Health Service, thereby placed on isolation and/or quarantined for a certain period for precautionary measures and/or medications.
- 3. Further, given the extended Enhanced Community Quarantine (ECQ), it resulted to strengthened restricted engagements and continued nonfunctional essential couriers and public transport system that hamper the regular movements of

the general public intending to transact business with government offices such as SOSIA and RCSUs, specifically in Luzon area.

- 4. In view of these considerations, of the extended ECO for Luzon that will last until April 30, 2020 as ordered by PRRD, as well as the PNP's pro-active measures in response to the threat of COVID-19, this Office strongly recommends the following:
  - a. Extension on the temporary suspension of transactions in CSG, SOSIA, and FEO to be extended until April 30, 2020 or until such time when transport or courier services normalizes. This factor is important as the clients of SOSIA and RCSUs need to submit documents and reports physically, Monthly Disposition Report (MDR) in particular consisting of hundreds of pages;
  - b. Include temporary suspension of transactions for all RCSUs throughout the country, except for the essential services enumerated under the above references and mining published and directives;

Those with License to Exercise Security Profession (LESP) and License to Operate (LTO) expiring within the enhanced quarantine period will be given extension until after the end of the 3<sup>rd</sup> Quarter of 2020 (September 30, 2020) with no penalties, to prevent bottleneck or sudden influx of persons and agencies trooping SOSIA, OSS, RCSUs for the renewal of their LESPs, LTOs and Permits; and

- d. All security guarus will be a provided that they are officially on duty, in proper uniform and can present their ID/License to exercise security profession (LESP), Duty Detail Order (DDO) & other pertinent documents.
- 5. That the said recommendations cited in paragraph 4, are hereby proposed in anticipation of the surge of applications come the stoppage by PRRD of the ECQ, and for humanitarian reasons in support to the call of the President of the Republic of the Philippines to aid the Filipino people who are affected, in one way or another, by the covid 19 pandemic that struck not only the country but the entire world, too.
