

SUBJECT: <b>Extension of Validity of PPA Approvals/ Permits During the ECQ, MECQ, and GCQ due to COVID-19 Pandemic</b>	
<b>MESSAGE:</b>  Disseminated herein is PPA Memorandum Circular No. 23-2020 "Extension of Validity of PPA Approvals/Permits During the ECQ, MECQ and GCQ due to COVID-19 Pandemic" issued in consonance with Administrative Order No. 30 issued by the Office of the President on 21 April 2020. Highlights of the Circular are as follows:  <ol style="list-style-type: none"><li>1. All pending applications for accreditation and Permit to Operate (PTO) received by the PPA/Port Management Office prior to or after March 15, 2020 are deemed approved for the purpose of doing business in the ports under PPA's jurisdiction, to be <b>valid until July 31, 2020</b>;</li><li>2. Hold Over Authority (HOA) to operate Cargo Handling (CH) services that expired or are expiring during the ECQ/MECQ/GCQ periods are deemed extended until <b>July 31, 2020</b>;</li><li>3. All other permits/certificates/authorizations issued by PPA/PMOs which are expiring by June 30, 2020 are also extended until <b>July 31, 2020</b>.</li></ol> The period of extension shall be non-extendible. In order to avoid the imposition of fines, charges and/or penalties, an application for extension or renewal should be filed on or before July 31, 2020.   <b>ISIDRO V. BUTASLAC, JR.</b>
