



<p>In view of the continuing implementation of International Ship and Port Facility Security (ISPS) Code and in compliance with the unnumbered Memorandum issued by the Assistant Secretary for Maritime of the Department of Transportation dated 24 August 2020 to ensure safety and security of the riding public as well as the port stakeholders in light of the recent twin bombing incidents that transpired in Jolo, Sulu last 24 August 2020, all Port Police Officers, Terminal Managers and security personnel detailed at PMO MOC are hereby directed to immediately implement Heightened Security Alert / intensified target-hardening measures, such as but not limited to, stringent screening, tighter access control and other protection measures as well as existing safety and health protocols within your area of jurisdiction.</p> <p>You are likewise advised to sustain intelligence build-up and closely coordinate with friendly forces and intelligence community operating within your AOR and report immediately thru the PMO's Command Center any information that may affect the port security for further assessment and validation.</p>	

This Advisory takes effect immediately and shall remain in force, unless sooner revoked or otherwise amended by this Office.
