In view of the recent weather bulletin issued by Philippine Atmospheric, Geophysical and Astronomical Services Adminstration (PAG-ASA) for Tropical Depression "Vicky" at 1400H 18 December 2020 of which ports under this PMO's Areas of Responsibility were placed under Tropical Cyclone Wind Signal #1 and in compliance to Sea Travel Advisory No. 1220-001 issued by the HQ of Philippine Coast Guard District – NoMin and Sea Travel Advisory No. 1 issued by Philippine Coast Guard Station – Camiguin, vessel trips at the Baseport and at the Terminal Ports of Camiguin and Balingoan are hereby suspended temporarily effective 0800H 18 December 2020.

### SEA TRAVEL ADVISORY NO.1

In reference to PAGASA Severe Weather Bulletin number 02 as of 8:00 AM today, December 18, 2020 Tropical Cyclone Wind Signal (TCWS) Number 1 was hoisted in Camiguin, Province and Balingoan, Misamis Oriental brought by Tropical Depression "VICKY".

In this regard, trips of vessels from Port of Benoni, Camiguin, Province to Port of Balingoan, Misamis Oriental and vice versa are all <u>CANCELLED</u>. Be guided on the HPCG Memorandum Circular No. 02-13 (Guidelines on Movement of Vessel during Heavy Weather). "No vessel on any type of tonnage shall be allowed to sail except to take shelter, as the situation may warrant, when Public Storm Warning Signal (PSWS) Number 1 or Higher is hoisted within its point of origin, the intended route, and point of destination."
