Please be guided that consistent with the Inter-Agency Task Force (IATF) Resolutions No. 24 and No. 53 dated 15 April 2020 and 9 July 2020, respectively, crew change is ONLY ALLOWED in the Port of Manila and ports authorized by the Department of Transportation (DOTr).

Accordingly, crew change/repatriation of Filipino and foreign crew in the Private Ports under the jurisdiction of the Authority is STRICTLY NOT ALLOWED.

MESSAGE:

- 1. Consistent with Inter-Agency Task Force (IATF) Resolution No. 24 dated 15 April 2020 and Resolution No. 53 dated July 9, 2020 (both copies attached), crew change is allowed only in the Port of Manila and ports to be authorized by the Department of Transportation (DOTr).
- 2. Accordingly, crew change/repatriation, both for Filipino and foreign crew, in Private Ports under PPA's jurisdiction is STRICTLY NOT ALLOWED.
- 3. Pending issuance of DOTr guidelines for crew change/repatriation of Filipino and foreign crew in other international seaports/gateways, it is reiterated that no crew

change/repatriation shall be allowed in all PPA ports, including private ports, except the Port of Manila.
