In view of the recent completion of road repair project on portions of 2 <sup>nd</sup> Avenue and	
2 <sup>nd</sup> Street inside the Port of Cagayan de Oro as reported by the contractor and affirmed	
by Engineering Services Division of this PMO, this Office hereby re-opens the	
aforesaid port thoroughfares to vehicle traffic.	
Anent thereto and in order to ensure safety of pedestrians and other road users all	

Anent thereto and in order to ensure safety of pedestrians and other road users, all vehicles traversing the road networks inside the port shall always observe the following port traffic rules and regulations, to wit:

- 1. Two-way traffic scheme while inside the port premises;
- 2. Limit the vehicle speed to 20 kph;
- 3. Slow down when approaching to an intersection;
- 4. Yield to pedestrians crossing the ports' designated pedestrian lanes;
- 5. Follow the directional and traffic signages installed on roadsides of the port.

In view thereof, PPA personnel, Oroport, shippers, consignees, truckers and other port stakeholders are advised to observe the aforesaid traffic rules and regulations at all times while inside the port premises.
