<b>MESSAGE:</b>  Respectfully disseminating herewith <b>Ordinance No. 14008-2021</b> passed by the City Council of Cagayan de Oro City during its Regular Session dated 11 January 2021 with the above captioned subject. As cited therein, it is necessary to prohibit the harvesting, gathering, buying, selling and mutilating of abaca to prevent further spread of abaca viral diseases and in order to conserve its species.  In view thereof, concerned PPA personnel, Cargo Handling Operators, ship owners/ship operators, shippers, consignees and other port stakeholders are advised to observe the provisions cited in the aforesaid Ordinance ( <i>herein attached</i> ), as appropriate.
