<p><b>MESSAGE:</b></p> <p>Disseminated herewith is the Unnumbered Memorandum dated 30 July 2021 from the PPA General Manger, Atty. Jay Daniel R. Santiago, directing all concern to comply with the strict implementation of border controls protocols particularly:</p> <ol style="list-style-type: none"> <li>1. PPA regulations on the filing of Notice of Arrival (NOA) and Application for Berth/Anchorage (ABA) shall be strictly enforced.</li> <li>2. Coordination shall be made, as applicable, with the Bureau of Customs (BOC), Bureau of Immigration (BI), Bureau of Quarantine (BOQ) and Philippine Coast Guard (PCG) on matters affecting border protocols.</li> <li>3. Crew change/disembarkation shall continue to be done only at PPA ports identified as crew change hubs.</li> <li>4. Ther shall be no boarding by pilots until submission of "Free Pratique" and clearance from the BOQ/Department of Health (DOH) Boarding Team</li> </ol> <p>These directives are pursuant to the Inter-Agency Task Force for the Management of Emerging Infectious Diseases (IATF) Resolution No. 130-A, Series of 2021, dated 29 July 2021.</p> <p>Please be guided accordingly.</p> <div style="text-align: center;">   <b>RUBY MARIA O.
