

Parol Making Contest 2022 Registration Form and Guidelines

A. Objective

This year's yuletide season, the PPA PMO MO/C will be having a **"Parol Making Contest,"** with its theme, ***"Parol sa Paglaum sa Maayong Kaugmaon."*** A Parol symbolizes the victory of light over darkness, faith, and hope.

The contest will be in line with the continuous implementation of Integrated Management System and Green Port Award System of the PMO, which aims to maintain the active participation of PPA regular and outsource employees on environmental activities and encourage the participants to incorporate strategies and actions for environmental protection, conservation and sustainability in their respective workplace amidst the challenges of the Post-Pandemic Transition defined by WHO as a *"decrease of pandemic surveillance due to a decrease in pandemic outbreak."*

B. Parol Design, Size and Materials

1. The Parol must be in traditional design and can be made of ANY locally available materials, such as but not limited to:
 - Any indigenous woven textile, malong, abaca skin, tinalak yakan, bamboo or
 - Dried leaves, niyog, nippa, and among others.
2. A minimum dimension of 30 inches in diameter, with no maximum limit in size and diameter.
3. It must be capable of being hung or propped up in a pole.
4. Lights and other miscellaneous objects used for the Parol can be plugged into any power source. However, please refrain from using substandard materials and practice precaution to prevent any untoward incident such as electrical overload

C. Prohibitions :

In compliance with PPA MC 11-2021 and PMO MO 001-19 on *"Ban on the Use of Unnecessary Single-Use Plastic Products"* the following plastics are **prohibited** to be used:

- Plastic bottles, plastic cups, plastic spoons/forks/ knives/stirrers and polystyrene containers

- Plastic labo, thin filmed sando bags
- Doypacks/ tetra packs

- Date of submission: 09 December 2022 at – 10:00 a.m. – 12:00 noon
- Place of submission: Passenger Terminal Building, Year End Fellowship Area

H. Registration Procedures

The contest is open to all regular and outsource personnel of the PMO-MOC. **Only one entry per employee.**

A number will be given to the participant upon submission of the registration form which will serve as the official entry number. As such, the participant must ensure that the number will be clearly visible and securely attached to the parol.



I. Disqualification

- Use of prohibited materials
- Non-compliance in **any** items of the Guideline and Registration Form.
- No entry number indicated in the Parol.

J. Removal and Disposal of the Parol

The participant is responsible for the Parol's maintenance as well as its removal and proper disposal outside the port premises by 06 January 2022. Failure to remove and dispose of the Parol will result in the prize being forfeited and a ban from participating in any subsequent PMO competitions of a similar sort.
