Respectfully disseminating herewith the Advisory issued by the Bureau of Immigration relative to the full-scale implementation of the e-Travel System on 15 April 2023 wherein crewmembers and passengers of vessels plying international voyages shall be required to register at *etravel.gov.ph* or scan the QR code which can be found in the attached Advisory.

As cited therein, please be further informed that the Bureau of Immigration shall discontinue requiring paper-based arrival/departure cards starting 01 May 2023.

In view thereof, concerned shipping lines/shipping agents and other port stakeholders are advised to observe the guidelines provided in the aforesaid Advisory (herein attached), as appropriate.

ADVISORY

Relative to the full-scale implementation of the e-Travel System, CREWMEMBERS and PASSENGERS OF ALL AIRCRAFTS AND SEACRAFTS shall be required, commencing on 15 April 2023, to register at etravel.gov.ph or scan the QR code below:

- Arriving passengers: Not earlier than seventy-two (72) hours from the scheduled time of arrival up to actual arrival into the country; and
- Departing passengers: Not earlier than seventy-two (72) hours up to not later than three (3) hours from the scheduled time of departure from the country.

BI shall discontinue requiring paper-based arrival/departure cards starting 01 May 2023.
