SUBJECT: EXIT ROUTE FOR OVERSIZED CARGOES/LARGE EQUIPMENT AND/OR OVERSIZED ROLLING CARGOES FROM THE PORT OF CAGAYAN DE ORO

MESSAGE:	
<p>This has reference to the accident occurred inside the Port of CDO wherein a large rolling cargo had struck and damaged the interlink wire fence of the Greenbelt Area while traversing the port's thoroughfare en route to Gate 3 – Exit, the designated exit point of all cargoes. Accordingly, the sharp turn and constricted/narrow road condition at the corner of 2nd Avenue and 1st Street leading to Gate 3 – Exit has been the root cause of the accident. As such road condition had offered difficulty to the driver in maneuvering left turn to exit the port specifically those with oversized rolling cargoes and/or trucks laden with oversized/large cargoes.</p> <p>In view thereof and to prevent recurrence of similar accident, the corner of 2nd Avenue and 2nd Street situated in between Area N and Area P shall be the alternate route of oversized rolling cargoes and/or trucks laden with oversized/large cargoes exiting from the Port of CDO. Hence, all other rolling cargoes and/or trucks laden with cargoes not classified as oversized, as may be determined by the Terminal Operations and CHO, shall take the normal direction en route to Gate 3 – Exit.</p> <p>For guidance and ready reference.</p> <p>FOR:  PPSUPT BERNARDO A GARTALIA</p> <p>Encl: A/S</p>
