<b>MESSAGE:</b> This has reference with the letter from the PSD Manager of PMO-MOC dated 07 June 2023 issued to Oroport Cargo Handling Services Inc with regard to the non-wearing of PPEs by port personnel at the ports' operational areas as noted during external and internal audits conducted in the Port of Cagayan de Oro.	
In view thereof and in line with the continuing implementation of Integrated Management System (IMS) in the Port of Cagayan de Oro, it is hereby reiterated that wearing of PPEs while at the ports' operational areas is mandatory. Hence, all port personnel/workers/users rendering works and/or transacting thereat shall comply to such requirement.	

The Port Police Division will apprehend port personnel/workers/users found to be violating the port safety and security regulations, particularly, among others, on the wearing of appropriate PPEs. They shall be brought to PPD Office for interrogation, documentation and imposition of appropriate sanction/s.
