SUBJECT: COMMISSION ON ELECTION (COMELEC) GUN BAN IN RELATION TO THE UPCOMING BARANGAY AND SANGGUNIANG KABATAAN ELECTIONS ON OCTOBER 30, 2023

MESSAGE: In view of the PMO's continuing implementation on the provisions of International Ship and Port Facility Security (ISPS) Code and National Security Programme for Sea Transport and Maritime Infrastructure (NSPSTMI), and in line with the upcoming Barangay and Sangguniang Kabataan Elections (BSKE) on 30 October 2023, please be respectfully informed that Comelec has implemented gun ban effective 28 August 2023 until 29 November 2023. Hence, the following activities are strictly prohibited while passing through the ports under PMO - Misamis Oriental/Cagayan de Oro during the aforesaid period, to wit: <ol style="list-style-type: none">1. Bearing, carrying or transporting of firearms and other deadly weapons outside residence or place of business, and in all public places.2. Employing, availing or engaging of the services of security personnel and bodyguards; and3. Transporting or delivering of firearms and explosives, including its parts, ammunition, and/or components. However, the above-mentioned activities may be allowed if authorized in writing by the Commission in accordance with the provisions of Comelec Resolution No. 10918 promulgated on 17 May 2023. Violators shall be dealt with accordingly pursuant to the penalties cited in the said Resolution. For information, guidance and strict compliance.  CPPO ZALDY E. MAGTAGAD
