WHEREAS, the Technical Working Group (TWG) was instructed by the Bids and Awards Committee (BAC) to conduct a post qualification Evaluation for **Arianos Construction** after the Bid Opening and Detailed Bid Evaluations were conducted whereby **Arianos Construction** was declared as the Lowest Calculated Bid (LCB) for the project **Supply of Materials**, **Labor**, and **Equipment for the Materials Recovery Facility**, **Port of Jasaan (MPF-MOC-50-2025)**

RESOLVED FURTHER to respectfully recommend to the Port Manager / Head of Procuring Entity (HOPE) that the project for the Supply of Materials, Labor, and Equipment for the Materials Recovery Facility, Port of Jasaan (MPF-MOC-50-2025) be awarded to Arianos Construction and that a Notice of Award is issued for this undertaking pursuant to Section 37 of the Revised IRR of RA 9184.
