Supply of Materials, Labor, Equipment for Materials Recovery Facility,
Port of Jasaan (MPF-MOC-50-2025)**

CONTRACT AGREEMENT

THIS AGREEMENT was made and entered into this 26th day of May 2025, in Cagayan de Oro City, Philippines, by and between:

PHILIPPINE PORTS AUTHORITY, a government corporation created under Presidential Decree No. 857, as amended, with principal office at PPA Building No.2, Port Area, Macabalan, Cagayan de Oro City, represented herein by its duly authorized Acting Port Manager **FERNANDO B. MAPALO, JR.**, hereinafter called the "Entity";

- and -

ARIANOS CONSTRUCTION (TIN # 908-315-927-000) is a private corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with business and office address at Purok 1A, Doongan, Butuan City, represented in this act by its duly authorized representative, **MR. RODERICK P. POLICARPIO**, and hereinafter referred to as "CONTRACTOR".

WHEREAS, the Entity is desirous that the Contractor execute the **Supply of Materials, Labor, Equipment for Materials Recovery Facility, Port of Jasaan (MPF-MOC-50-2025)** (hereinafter called "the Works") and the Entity has accepted the Bid for **One Hundred Ninety-Eight Thousand Fifty-Four and 95/100 (P198,054.95)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - a. Philippine Bidding Documents (PBDs);
 - b.
 - i. Drawings/Plans;
 - ii. Specifications;
 - iii. Bill of Quantities;
 - iv. General and Special Conditions of Contract;
 - v. Supplemental or Bid Bulletins, if any;
 - c. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;





Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- d. Performance Security;
 - e. Notice of Award of Contract and the Bidder's conforme thereto; and
 - f. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. The winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration for the sum of **One Hundred Ninety-Eight Thousand Fifty-Four and 95/100 (P198,054.95)** or such other sums as may be ascertained, **ARIANOS CONSTRUCTION** agrees to undertake and complete the works in accordance with the required specifications and remedy any defects therein in conformity with the provisions of this Contract and Contract Documents and in accordance with his/her/its Bid.
4. The *Port Management Office of Misamis Oriental/Cagayan de Oro* agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
