




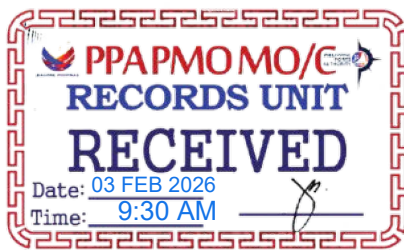

MESSAGE: As part of PPA's commitment to provide safe, efficient and quality frontline services to all port clientele at all times and strive to continually review and revise existing systems in order to attain PPA's goals and objectives, the Mobile Point of Sale (MPOS) system has been implemented nationwide to replace the existing manual process of issuing pre-printed cash tickets . The Mobile Point of Sales (MPOS) System constitutes one of the primary components of the PPA's revenue collection infrastructure. For ports under the jurisdiction of PMO Misamis Oriental/Cagayan de Oro, the rollout of MPOS is scheduled below: <u>February 12, 2025</u> Port of Cagayan de Oro (Baseport) Port of Balingoan (TMO Balingoan) <u>February 13, 2025</u> Port of Opol (TMO Opol) Port of Benoni (TMO Camiguin) Port of Balbagon (TMO Camiguin) This improvement aims to further enhance operational efficiency, streamline payment transactions, and improve service delivery within the said ports. 
SUBJECT : **CONDUCT OF ROLLOUT OF THE MOBILE POINT OF SALE (MPOS) SYSTEM**
